Status of an attorney, after Court order, who: failed to pay the annual fee and/or file the form required by subdivisions (a) and (d) of Enforcement Rule 218; was reported to the Court by the Pennsylvania Continuing Legal Education Board under Rule 111(f), Pa.R.C.L.E., for having failed to satisfy the requirements of the Pennsylvania Rules for Continuing Legal Education; failed to pay any expenses based pursuant to Enforcement Rule 208(g); or failed to meet the requirements for maintaining a limited law license as a Limited In-House Corporate Counsel; a foreign legal consultant; an attorney participant in defender and legal services programs pursuant to Pa.B.A.R. 311; or a military attorney.

Experience has shown that this is going to get a lot more interesting. As successor to Ms. Stapleton, it would appear that [Roberta A. DeAngelis](#) now holds the baton with respect to the WebSci scandals. However, the existence of pending investigations by the **FBI** or other Federal or Congressional authorities may impede self directed efforts within the **EOUST** to clean up this particular mess.
